- No damage to towels (if provided by us), linens, curtains and/or kitchen towels. Please place all soiled linens on bathroom floor upon check-out. Charge will apply for extra soiled linens/bedspreads/mattress covers.
- Return all keys, \$100 fee will apply for lost key(s).
- Sweep excessive debris (dirt/mud/sand) brought in and mop stains/spills caused to floors during your stay.
- No damage to building, grounds and cabin contents.
- NO SMOKING in cabins (\$250 penalty and all guests in your party will be asked to leave immediately, absolutely no refunds).
- No pets (\$250 penalty and all guests will be asked to leave immediately, absolutely no refunds).
